

CRYSSS - Supplementary Information

In accordance with the YCNI funding policy, all organisations wishing to access the CRYSS Scheme must demonstrate that:

- They can meet YCNI's basic criteria AND
- YCNI's test for a regional organisation.

For those organisations NOT in receipt of Infrastructure Support Funding or Thematic Infrastructure Support Funding for 2009/2010, the following supplementary information must be submitted along with the CRYSSS application form.

1.3.	Your organisation must be a "not for profit" organisation.

YCNI will assume this to mean financial solvency according to the organisation's balance sheet and reserves the right to seek expert opinion on this matter.]</i>

STAGE 2 – REGIONAL TEST

Direct Provision
